### **ORDER:**

The Director of Rural Development and Panchayat Raj in his letter third read above has stated that in Government Letter Lr.No.6977/CGS-2/2017-1 dated 03.04.2017, the details of State Share due for 2016-17 under Pradhan Mantri Gram Sadak Yojana has been communicated and its letter dated 6.4.2016 Ministry of Rural Development has fixed Rs.204 Crore as Central Share and Rs.136 Crore as State Share for 2016-17 for Pradhan Mantri Gram Sadak Yojana. He has also stated vide letter No.P-17017/1/2016-RC(FMS No.347396) dated 22.02.2017, the Ministry of Rural Development has released Rs.50 Crore additionally for 2016-17 raising its share from Rs.204 Crore to Rs.254 Crore (Central share) and vide letter No.17025/34/2016-RC EFMS(350527) dated 15.03.2017, Ministry of Rural Development has revised the matching State Share for 2016-17 as Rs.169 Crore (Rs.254 Cr x 40/60 = Rs.169 Cr).

2. The Director of Rural Development and Panchayat Raj has also stated that in the Government Order first read above the Government had accorded sanction to release a sum of Rs.66.47 Crore as corresponding State matching share under Pradhan Mantri Gram Sadak Yojana for the year 2016-17. In the Government Order second read above the Government had accorded sanction to release a sum of Rs.65.68 Crore as corresponding State matching share under Pradhan Mantri Gram Sadak Yojana for the year 2016-17. Accordingly the first release of State share has been fully drawn while the second instalment has been restricted to Rs.65.56 Crore

owing to the incorrect F.M.A. fixed as Rs.471.559 Crore instead of Rs.471.679 Crore for 2016-17. Therefore the drawal for 2016-17 towards State share was only Rs.132.03 Crore and the balance due of State share for 2016-17 is Rs.36.97 Crore (Rs.36.85 Cr.+Rs.0.12Cr.). The Ministry of Rural Development Rural Development / Government of India is insisting for the release of entire State share release in matching with central share for further release.

3. The Director of Rural Development and Panchayat Raj has further stated that Central share of Ministry of Rural Development for the year 2016-2017 under Pradhan Mantri Gram Sadak Yojana is Rs.254 Crore (original indicative annual allocation is Rs. 204 Crore + incentive Rs.50 Crore) and the matching State Share is Rs.169 Crore. As the State Government has released Rs.132.03 Crore out of Rs.169 Crore. The Director of Rural Development and Panchayat Raj has requested to release balance State share of Rs.36.97 Crore (Rs.169 Cr. – Rs.132.03 Cr.) under PMGSY for the year 2016-17 so as to get the further release.

4. The Government after careful examination have decided to accept the proposal of Director of Rural Development and Panchayat Raj and accord sanction a sum of Rs.36.97 crore (Rupees Thirty Six Crore and Ninety Seven Lakh only) as corresponding State matching share under PMGSY for the year 2016-17.

5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-

4515-00-CAPITAL OUTLAY ON OTHER RURAL DEVELOPMENT PROGRAMMES – 103 – Rural Development – State's Expenditure JG – Roads and Bridge works under PMGSY-Bharat Nirman – 16 Major works. (DPC 4515-00-103-JG-1608)

6. The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned at para 4 above.
