**ORDER:**

In the letter read above, the Director of Rural Development and Panchayat Raj has stated that Ministry of Rural Development has released a sum of Rs.1,81,98,500/- (Rupees One Crore Eighty One Lakh Ninety Eight Thousand and Five Hundred only) towards "Administrative Funds" to State Government of Tamil Nadu under Pradhan Mantri Gram Sadak Yojana (PMGSY) for 2017-18.


