



## **ABSTRACT**

Centrally Sponsored Schemes – Pradhan Mantri Gram Sadak Yojana – Release of a sum of Rs.37.05 Crore (Rupees Thirty Seven Crore and Five Lakh only) as Financial Incentive to State Government of Tamil Nadu as State matching Share for periodic maintenance of roads already constructed under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2016-17 - Orders – Issued.

**ORDER :**

In the letter second read above, the Director of Rural Development and Panchayat Raj has stated that Ministry of Rural Development, Government of India has released Rs.55.58 Crore as Financial Incentive under Central Assistance of Pradhan Mantri Gram Sadak Yojana Scheme for the year 2016-17. This released amount is exclusively meant for periodic maintenance of roads already constructed under Pradhan Mantri Gram Sadak Yojana after the post 5 year maintenance. The amount has already been drawn and credited to Tamil Nadu Rural Housing and Infrastructure Development Corporation and the Ministry of Rural Development has insisted that proportionate matching State Share has to be released for periodic maintenance of roads. A length of 842 Km have been identified under periodic maintenance for the year 2017-18. The State share under 60:40 formula works out to Rs.37.05 Crore (55.58\*40/60). The Ministry of Rural Development has requested for early State matching Share credit during the Review Meeting.



2. In the Government Order first read above, the Government have sanctioned a sum of Rs.55.58 Crore as Financial Incentive to State Government of Tamil Nadu as Central assistance under Pradhan Mantri Gram Sadak Yojana for the year 2016-17.

3. The Director of Rural Development and Panchayat Raj has therefore requested the order of the Government on the following:

- (i) to sanction a sum of Rs.37.05 crore as corresponding State matching Share to the extent of Central release of Rs.55.58 Crore as Financial Incentive to State Government of Tamil Nadu for periodic maintenance of roads already constructed under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2016-17 under the following head of account:

“4515-00-Capital outlay on Other Rural Development Programmes – 103 – Rural Development – State's Expenditure – JG – Roads/Bridge works under PMGSY-Bharat Nirman – 16 Major works.

(DPC 4515-00-103-JG-1608)”

- (ii) to authorize the Director of Rural Development and Panchayat Raj to draw and disburse the amount to Tamil Nadu Rural Housing and Infrastructure Development Corporation account.

4. The Government, after careful examination have decided to accept the proposal of Director of Rural Development and Panchayat Raj and accord sanction for a sum of Rs.37.05 Crore (Rupees Thirty Seven Crore and Five Lakh only) towards Financial Incentive to State Government of Tamil Nadu as State matching Share for periodic maintenance of roads already constructed under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2016-17.

5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-

4515-00-Capital outlay on Other Rural Development Programmes – 103 – Rural Development – State's Expenditure JG – Roads/Bridge works under PMGSY-Bharat Nirman – 16 Major works.

6. The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned at para 4 above to Tamil Nadu Rural Housing and Infrastructure Development Corporation account.
