**ORDER:**

In the Government order first read above, orders were issued accepting the recommendations on the devolution of resources from the State Government to Local Bodies under Fifth State Finance Commission.

2. In the Government Order second read above, orders were issued sanctioning a sum of Rs.257,96,99,500/- out of Rs.515,93,99,000/- as first instalment for the year 2017-18 towards Pooled Fund for deficit Rural Local Bodies.

3. In the letter third read above, the Director of Rural Development and Panchayat Raj has informed that as per the order second read above, out of the released amount of Rs.257,96,99,500/- a sum of Rs.216,09,00,000/- has been disbursed to the TANGEDCO as one time settlement towards the settlement of Current consumption charges pending beyond 60 days and a sum of Rs.40,18,79,800/- has been released to the TWAD Board to meet deficit on Combined Water Supply Scheme.

4. The Director of Rural Development and Panchayat Raj has therefore requested the Government to sanction the balance amount of Rs.257,96,99,500/- as second instalment under Pooled Fund for Deficit Rural Local Bodies for the year 2017-18.

5. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj at para 4 above decided to accept the same and accord sanction for Rs.257,96,99,500/- (Rupees Two Hundred and Fifty Seven crore Ninety Six Lakh Ninety Nine Thousand and Five Hundred Only) as second instalment under Pooled Fund for Deficit Rural Local Bodies for the year 2017-18.


