ORDER:

In the Government Order first read above, amendments were issued to the Special Rules for the Tamil Nadu Ministerial Service, incorporating the posts of Steno-Typist Grade-III, Steno-Typist Grade-II and Steno-Typist Grade-I. In the Government Order second read above, orders have been issued improving the promotional avenues to the post of Steno-Typist Grade-III and Steno-Typist Grade-II. Accordingly, necessary amendment to the Special Rules for the Tamil Nadu Ministerial Service are issued.

2. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Ministerial Service (Section 22 in Volume – III of the Tamil Nadu Services Manual, 2016)..

2. The amendment hereby made shall be deemed to have come into force on the 25th July 2018.

AMENDMENT.

In the said Special Rules, in rule 5B, for clauses (i) and (ii), the following clauses shall be substituted, namely :-

"(i) The fully qualified approved probationers in the category of Steno-Typist Grade-III opting to remain in the Steno-Typist category alone shall be considered for promotion to the category of Steno-Typist Grade-II. On such promotion, they shall be attached to the second level officers except the officers one level below to the Heads of the Department, where more than one level of posts of second level officers exist:

Provided that a Steno-Typist Grade-III, on completion of 15 years of service in that post shall be considered for upgradation as Steno-Typist Grade-II.

(ii) Steno-Typist Grade-II, shall be considered for promotion to the category of Steno-Typist Grade-I. On such promotion, they shall be attached to the Heads of the Department. They shall also to be attached to the officers one level below to the Heads of the Department, where more than one level of posts of second level officers exist:

Provided that a Steno-Typist Grade-II, on completion of 15 years of service in that post shall be considered for upgradation as Steno-Typist Grade-I."
