ORDER :

In the letter read above, the Director of Rural Development and Panchayat Raj has stated that the Government of India have revised the sharing pattern under Pradhan Mantri Gram Sadak Yojana was communicated by Ministry of Rural Development of Government of India in November 2015 and the funding by Government of India and State for 2017-18 for Pradhan Mantri Gram Sadak Yojana has been issued in Ministry of Rural Development, Letter No.P-17017/4/2017-RC, dated 22.02.2017. According to the communication, the Centre's Share for 2017-18 will be Rs.400 crore and State Share will be Rs.266.67 Crore. Based on the allotment, Government of India in Letter No.P-17024/24/2014-RC (EFMS No.341716), dated 27.04.2017 have sanctioned a sum of Rs.57.4784 Crore to the State Government of Tamil Nadu as Central assistance under Pradhan Mantri Gram Sadak Yojana Phase IX for the year 2017-18. Subsequently, the Government vide G.O.(D) No.295, Rural Development and Panchayat Raj(CGS-2) Department, dated 6.6.2017, have sanctioned a sum of Rs.57.4784 Crore as Central assistance under Pradhan Mantri Gram Sadak Yojana Phase IX for the year 2017-18. Further, in

G.O.(Ms) No.96, Rural Development and Panchayat Raj (CGS-2) Department, dated 24.8.2017, Government have sanctioned a sum of Rs.38.29 Crore as corresponding State matching share under Pradhan Mantri Gram Sadak Yojana Phase IX for the year 2017-18.

2. The Government of India in Letter No.P-17024/24/2014-RC (EFMS No.341716), dated 25.07.2017 have sanctioned a sum of Rs.138.1466 Crore to the State Government of Tamil Nadu as Central assistance under Pradhan Mantri Gram Sadak Yojana Phase IX for the year 2017-18. Subsequently, Government vide G.O.(D) No.458, Rural Development and Panchayat Raj (CGS-2) Department, dated 15.09.2017 have sanctioned a sum of Rs.138.1466 Crore as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) Phase IX for the year 2017-18.

3. The Director of Rural Development and Panchayat Raj has also stated that since the scheme is to be funded by both Centre and State, the State Share to that extent need to be released. The State Share allotted by Ministry of Rural Development is Rs.266.67 Crore for the year 2017-18. The works taken under Phase IX (2014-15) have already been completed and Phase X (2016-17) works are in advanced stages.

4. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue order for the release of Rs.92.0977 Crore as corresponding State matching share to the extent of Central release of Rs.138.1466 Crore under Pradhan Mantri Gram Sadak Yojana Phase IX for the year 2017-18.

5. The Government, after careful examination have decided to accept the proposal of Director of Rural Development and Panchayat Raj and accord sanction a sum of Rs.92.0977 Crore (Rupees Ninety Two Crore Nine Lakh and Seventy Seven Thousand Only) as State matching Share under Pradhan Mantri Gram Sadak Yojana (PMGSY) Phase IX for the year 2017-18.

6. The expenditure sanctioned in para 5 above shall be debited under the following head of account :-

4515-00-Capital outlay on Other Rural Development Programmes – 103 – Rural Development – State's Expenditure JG – Roads/Bridge works under PMGSY-Bharat Nirman – 16 Major works.

7. The Director of Rural Development and Panchayat Raj is authorized to draw and transfer the amount sanctioned at para 5 above to Tamil Nadu Rural Housing and Infrastructure Development Corporation account.
